ORDER

NAGAR, BHOPAL, PIN CODE - 462002, MADHYA PRADESH to JAWAHARLAL NEHRU COLLEGE OF PHYSICAL EDUCATION, PLOT NO. 973/1, 974/2/2, 977/2/2, 978/2/2, 978/1/2, 1026, 1004/1, 1008, 1011, 1010, 1027, 1028, 1029, 1025/1, 1025/2, 1030, VILLAGE - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, TOWN/CITY/DISTRICT - BHOPAL, PIN CODE - 462002, MADHYA PRADESH.

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 30.01.2016

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 242nd Meeting held on February 11-13, 2016. The Committee decided as under:-

"...This is a case of shifting. The institute runs the B.Ed. course with two units, B.P.Ed., M.Ed. and M.P.Ed. courses with one unit each and it has applied for the D.El.Ed. course. The CD was viewed and VT report was perused. The CD shows a good building with adequate infrastructural and instructional facilities. The institute has sufficient land and built up area to run the above mentioned courses. The VT has recommended the case. Hence, the institute is permitted to shift."

NOW THEREFORE, in exercise of the powers vested under section 15(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from JAWAHARLAL NEHRU COLLEGE OF EDUCATION, 56-C, SHYAMALA HILLS OPP.
